***Proposed Local Laws 12 relating to the new hamlet MFZ was introduced on August 19, 2021 and noticed in the Daily Freeman on August 21, 2021. This Law was referred to the Ulster

County Planning Board, Town of Esopus Planning Board and neighboring municipalities . The law has been available for review in the Town Clerk's office and online at www.esopus.com.

Overview of Law - presented by Matt Rogers

This law has no impact on any other properties it is solely a rezoning of the parcel located between First Place auto and the Port Ewen Diner. A full presentation of the project had been given at a prior meeting. There will be a total of 17 units housed with in 2 buildings including office space and multifamily apartments the other building will be tow homes. Outdoor patios a small pocket park and 2 charging stations are some of the amenities the project will bring. After this law is approved, it will go to the Planning Board for site plan approval. The law establishes the rezoning of the property. If there are significant changes to the design that had been presented, they will need to come back before the Town Board.
