Resolution to Adopt a Determination of Non-significance
Regarding Environmental Impact
October 1, 2019

Whereas, the Town of Esopus intends to undertake a capital improvement on behalf of the Port Ewen Water District that involves the replacement of a 2.0 Million Gallon Water Storage Tank immediately adjacent to the existing Water Storage Tank; and

Whereas, the project requires that an Environmental Review be conducted pursuant to Article 8 of the Environmental Conservation Law, Part 617 of NYCRR (SEQRA); and

Whereas, on August 20, 2019 the Town Board declared its intent to be lead agency and commenced a coordinated review with the other involved agencies; and

Whereas, the other involved agencies were sent notification of this intent and a Long Form EAF; and

Whereas, the other involved agencies have either consented to the Town Board being Lead Agency or did not respond within the 30 day period.

Therefore, be it resolved that after careful consideration, analysis and review, the Town Board, as Lead Agency, determines that the Action will not have a Significant Impact on the Environment and that a Determination of Non-significance (Negative Declaration) shall be adopted and that an Environmental Impact Statement will not be required, and;

Be it further resolved that the Town Clerk is hereby authorized and directed to file the Negative Declaration and any appropriate notices of this determination in accordance with 6 NYCRR Part 617.12(b).

- The reviewer is not expected to be an expert in environmental analysis.
- If you are not sure or undecided about the size of an impact, it may help to review the sub-questions for the general question and consult the workbook.
- When answering a question consider all components of the proposed activity, that is, the “whole action”.
- Consider the possibility for long-term and cumulative impacts as well as direct impacts.
- Answer the question in a reasonable manner considering the scale and context of the project.
